7. That he has not, and never did, solicit, conspire, conjure nor manipulate other parties to act as a disinformation specialist for the expressed purpose of hoaxing, forging, or fabricating the alleged Majestic documents et. al. in question.

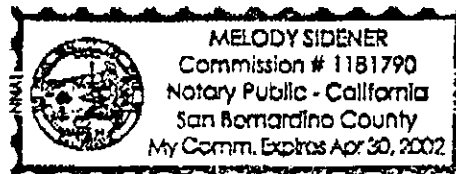

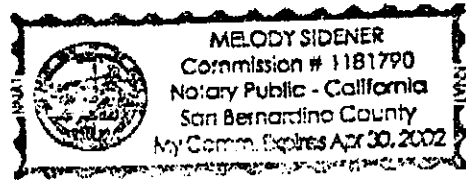
