REPORT OF THE DEPARTMENT OF DEFENSE

SECTION I


Department of Defense actions in support of approved plans and guidance cited below are as indicated.

1. National Security Council

a. NSC 59/1, "The Foreign Information Program and Psychological Warfare Planning," 9 March 1950: No major developments resulted during this quarter except for general support as indicated in Section II.

b. NSC 127/1, "Plan for Conducting Psychological Operations During General Hostilities," 25 July 1952: Support of this plan is as indicated in paragraph 3, Section I.

d. NSC 10/5: Continuous coordination has been effected in Psychological Strategy Board (PSB) review staff planning (see Section II), and operational and logistical support has been furnished as required.

2. Psychological Strategy Board

a. Presidential Directive of 4 April 1951: The Department of Defense has appointed a member and a military advisor to the PSB review staff, and has acted upon PSB guidances as indicated below.

b. PSB J-19-d, "Emergency Plan, Breakoff of Korean Armistice Negotiations," 18 September 1951: Supporting plans promulgated during previous quarters have been distributed to appropriate commanders.

c. PSB D-7/c, "Psychological Operations Plan Incident to Korean Cease Fire Negotiations", 25 October 1951: Supporting plans promulgated during previous quarters have been distributed to appropriate commanders.

d. PSB D-11/b, "National Overt Propaganda Policy Guidance for General War", 15 November 1951: Supporting plans have been incorporated in war plan as previously reported; detailed themes are now being developed.
